6.	This Declaration of Lost Monetary Instrument is rendered for the purpose of obtaining the substitution for said Instrument from Banco Popular de Puerto Rico for another Instrument for the same amount.

The Signers agree to appear and defend the Bank if a lawsuit or action is placed against the Bank, based or relating to the Instrument; in which cas will pay, at their cost, the expenses, fees, and adjudication relating to said action or suit. If the Signers' Declaration result false, they will pay, at their own cost, the expenses, fees, and adjudication relating to said action or suit.			
8.	The Signers convene and agree that, in the event that the Instrument is found and reaches the Signers possession, it will be returned to the Bank for its final disposition.			
9.	If this Declaration of Lost Monetary Instrument is about a foreign currency draft, the Signers will be obliged to pay any charges and accept any delays from the Correspondent Bank before funds reimbursement. The Signers acknowledge that Banco Popular will reimburse the net amount after the conversion rate and corresponding charges are applied.
