A report has been sent to the Office of the Commissioner of Financial Institutions (the "Commissioner") for the International Banking Center of Banco Popular de Puerto Rico, in accordance with applicable laws, on unclaimed amounts until June 30, 2020 (the "Report"). The Report is confidential, since it includes personal information, and includes amounts with balances of less than one hundred (100) dollars not published in this NOTICE.

A copy of this NOTICE will be available, until November 30, 2020, for public inspection at a visible and accessible place at the office of the International Banking Center of Banco Popular de Puerto Rico, located at 1500 Ave Ponce De Leon, Esq. Pavia Street, 7th Floor, 22nd Stop, Santurce, PR and also at

our web portal www.popular.com. Any person that desires to obtain information regarding any unclaimed accounts in his/her name with balances of less than one hundred (100) dollars must visit the aforementioned office.

The amounts claimed will be payable in the office of the International Banking Center of Banco Popular de Puerto Rico previously mentioned, on or before November 30, 2020, to the persons that proof their right to collect them. Expenses incurred in sending the written communications required by the applicable Law will be charged proportionally against the amount claimed.

The unclaimed funds as of November 30, 2020 will be sent to the Office of the Commissioner on December 10, 2020 and all responsibility of the International Banking Center of Banco Popular de Puerto Rico will cease in relation to said funds. After December 10, 2020, all claims must be processed through the Commissioner.
